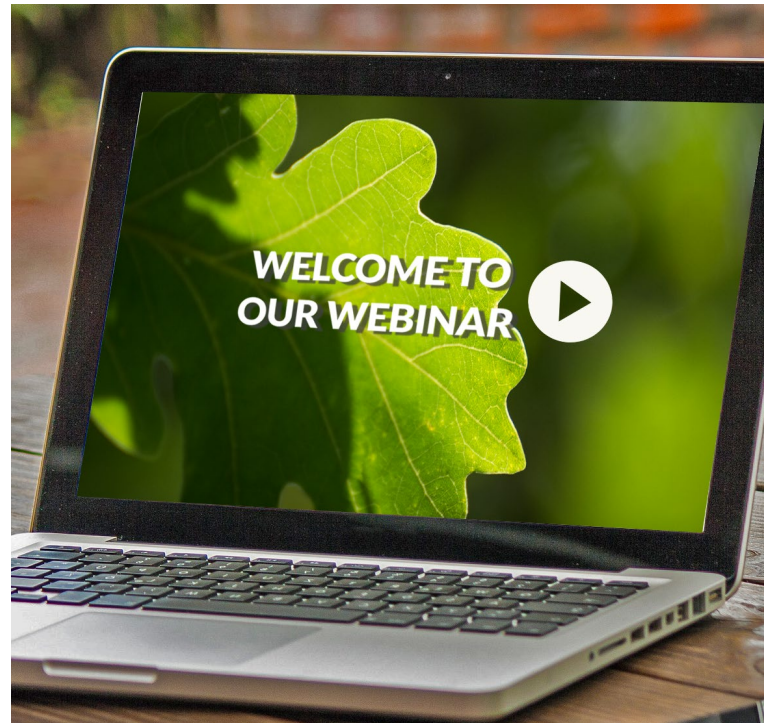

It outlines a way to provide moms who are at risk of state intervention an empowering alternative to foster care and state adoption for children ages 0-3. At OA&FS, she can create an open adoption in which she chooses, meets and forms an ongoing extended family relationship with the adoptive parents. In our high-integrity adoptions, family preservation is achieved by adding family and support. We provide lifelong services, including counseling and relationship guidance.
