

2008-2009 Annual Report



Dear Friends,

Over the past year, adoption has changed tremendously, not only across the U.S., but around the world.

The U.S. recently ratified the **Hague Convention on**

International Adoption, bringing stricter guidelines and regulations to international adoptions. As international adoption practices were examined closely, significant corruption was uncovered. It was determined that in many countries children were being placed for adoption without their birthparents' consent. Unable to meet new regulations, programs in nearly half of the 40 countries which provide international adoptions to the U.S. were closed, temporarily or permanently. Countries in which the global economy created an emerging middle class established their own domestic adoption agencies, enabling children to remain in their country of origin. These monumental changes resulted in a 20-50% decline in international adoptions to U.S. families, depending on the country.

Consequently, families in the U.S. are returning their focus to domestic adoption. As the Northwest leader of infant domestic adoptions, we welcome this attention. For nearly 25 years, **Open Adoption & Family Services** (**OA&FS**) has guided and supported birth and adoptive families as they create strong and healthy open adoption relationships that truly honor the needs of the child. **By educating the public about our unique adoption model, we have a lot to offer the changing world of adoption.**

In Oregon, new regulations require that prospective adoptive parents take an adoption preparation class. OA&FS specifically designed a class that brings our unique philosophy and experience to these families, who are commonly adopting through attorneys. Previously, these families have not had the benefit of our open adoption relationship preparation and guidance. We are very excited to be able to impact these adoptions in such a positive way.

We also brought our services to birthparents in Oregon who are at risk of having their parental rights terminated by the state. Through our very successful collaborative relationship with the **Oregon Department of Human Services (DHS)**, we have trained over 200 caseworkers and supervisors regarding the benefits of providing these birthparents with an alternative open adoption track. Last year 19% of the children we placed were at risk of entering the state foster care system. This year that number rose to 29%. We are extremely proud of this increase. Next year we plan to bring these trainings to Washington.

2008-2009 Highlights

Reaching Out to Professionals

In the past fiscal year, OA&FS conducted outreach presentations to over 2,500 health professionals, social workers, teachers, counselors, public health workers and state adoption caseworkers throughout Oregon and Washington regarding our unique open adoption services.

OA&FS has trained over 200 Oregon **DHS** caseworkers about our services. Having the ability to make a voluntary adoption plan through OA&FS supports birthparents in making a proactive choice, provides the child immediate permanency and diverts a case away from the already overburdened state system.

Every year approximately 25% of the estimated 13-14,000 females nationwide that voluntarily plan adoptions, are teenagers. In the past fiscal year, OA&FS has worked to ensure this age group receives up to date information about adoption. Agency staff reached out to the Planned Parenthood Teen Councils and teen parent support groups in the region. At last year's Adolescent Sexuality **Conference**, OA&FS counselor **Jodi Bernstein** presented a lively workshop. This year, OA&FS Executive Director Shari **Levine** continues to serve on the planning committee for the conference. In addition, OA&FS counselor **Satya Kline** presented a workshop at the 2009 Oregon School-Based **Clinic Conference**, which was extremely well-received. Additionally, throughout the year, OA&FS counselors shared information about open adoption to over 350 teens attending public and alternative high schools, and the professionals that work with them.

Oregon and Washington have recently created state mandates for earlier and more comprehensive sex education in public schools. OA&FS saw this as an ideal opportunity to increase access to adoption resources for students and to increase adoption-related trainings for teachers, counselors and school nurses. As the Co-Chair of the **Teen Pregnancy and Young Parent Network for Multnomah County** and board member of the **Oregon Teen Pregnancy Task Force**, **Shari** has made great strides towards the inclusion of pregnancy options counseling (including adoption) as part of sex education in schools. Through these efforts, OA&FS has networked extensively and created trusting relationships with a variety of agencies that serve pregnant teens.

Reaching Out to the Latino Community

OA&FS began its Latino outreach program in 2006. Since then, the agency has hired a Spanish-speaking counselor in the Portland office, produced Spanish-language materials about the agency, and established a toll-free Spanish phone line. Current

research from the **National Campaign to Prevent Teen and Unplanned Pregnancy** has indicated that 53% of Latinas in the U.S. will have at least one pregnancy before the age of 20; and 69% of pregnant Latinas will drop out of high school. These findings have reinforced the need for our continued outreach to the Latino communities in Oregon and Washington.


Throughout the past fiscal year, OA&FS staff conducted outreach to the Latino community and health professionals that serve this growing population. Among other venues, the agency shared information at the **Latino Health Fair** and the **Multnomah County Skills Fair**, both held in Portland, Ore. Additionally, OA&FS' bilingual counselor, Jessica Gibson, has networked extensively with other professionals that serve the Latino community by attending conferences and events, such as the **Latino Summit**.

Kristel Nelsen, president of **Picante Solutions**, generously donated in-kind consulting services from her Hispanic marketing firm. After working with Kristel, OA&FS placed Spanish-language advertisements in Oregon and Washington phone books and produced bilingual information panels to display at community events and during outreach presentations.

Rain Or Shine

In order to create a vehicle for families to discuss open adoption with their children, OA&FS published "Rain or Shine," one of the first children's books about open adoption families.

To promote the book, the agency listed its availability on the OA&FS Web site and sent an e-announcement about the book to over 300 adoption agencies, attorneys

and adoption support organizations. OA&FS also sponsored a free reading of "Rain or Shine" by adoptee and OA&FS Board Member David Tilchin in an open house held at the Portland office as part of the 2008 Adoption Fair.





Expanding Services in Eastern Oregon and Washington

After social service agencies in the eastern regions of Oregon and Washington expressed a need for adoption services in their geographic area, OA&FS developed a sustainable growth plan to expand services for these often rural communities.

In 2008 OA&FS completed presentations to over 75 health care professionals in Eastern Oregon and Washington, including training about open adoption for child welfare workers working with families facing state involvement. The agency also conducted several outreach presentations in Eastern Washington. Goals for the next fiscal year include continuing to build a client-base in the eastern portion of both states.

Lifegivers

In the last fiscal year, OA&FS doubled its efforts to support birthparents, offering a **Lifegivers** retreat in

chance to create support networks with their peers. For the past seven years, the event has provided activities and discussions that honor birthmothers. Thanks to monetary donations, in-kind donations, and creative writing donations honoring birthmoms, 42 birthmothers participated in the 2009 **Lifegivers** retreats.

Pregnancy Options Dialogue



In 2009, along with event partners Backline, Planned Parenthood of the Great Northwest, and the Center for Health Training, OA&FS organized the Pregnancy Options Dialogue, a workshop for healthcare professionals.

At the dialogue to be held in Seattle on **October 23**, providers will strengthen their ability to talk about pregnancy, parenting, abortion and adoption when offering services for women and families.

Service Statistics

July 1, 2008 through June 30, 2009

OA&FS Clients

- Last fiscal year there were an average of 46 families waiting in the OA&FS prospective adoptive parent pool.
- On average, adoptive parents waited 10 months before being chosen by birthparents.
- Gay and lesbian adoptive parents waited an average of 13 months before being chosen by birthparents. Placements with gay and lesbian families totaled 14 (30% of the total).
- Adoptive parents and birthparents agreed upon an average of three visits per year in their Open Adoption Agreements.

Nearly all families (98.8%) that have adopted through OA&FS speak about openness when discussing adoption.


From 2008 Survey of OA&FS Clients

- Birthparents received an average of eight weeks of counseling prior to placement.
- The average age of birthmothers was 25 years old, 28 for birthfathers and 40 for adoptive parents.
- Of the children placed, 87% were newborns.
- Of the children placed, 43% were female and 57% were male; 79% were Caucasian, 17% of mixed ethnicity, 2% Hispanic and 2% African-American.
- Nearly three-quarters (74%) of the children placed had zero to mild prenatal exposure to drugs or alcohol; almost half (49%) had no exposure; 25% had mild exposure; 11% had moderate exposure; and 15% had severe exposure.

OA&FS Placements

- During the last fiscal year, OA&FS completed 53 adoptions.
- The agency also assisted three families with placements through other resources. On average the agency completes 45 to 60 adoptions per year.
- 14% of placements involved no pregnancy-related expenses; 86% of placements involved an average of \$904 in pregnancy-related expenses.

Type of Placements



Standard Open Adoption: The agency brings together adoptive parents and birthparents and provides adoption planning prior to the birth of the child.

Last-Minute Placement: Birthparents contact the agency to plan an adoption during delivery or shortly after the baby has been born.

Identified Adoption: Birthparents and adoptive parents find each other outside of the agency process and come to the agency for adoption planning and placement services.

In 2008-2009, OA&FS:

- Responded to 220 calls from women facing unplanned pregnancies.
- Answered 360 information calls from prospective adoptive parents.
- Hosted events attended by 522 members of the open adoption community.
- Shared information about open adoption with over 2,500 professionals and students.
